

Golden Valley News for January 2012

This is my last issue of the GVL newsletter. I'm happy to report that Laurie Taylor has volunteered to take over as your editor starting next month. I'm sure she will do a great job.

I started writing the newsletter three years ago, in February 2009 – it's hard to believe how quickly time has gone by. For the year ahead I plan to continue writing a column appearing under the headline 'Chairman's Message'. Of course, it's up to Laurie what to publish in her newsletter.

Chairman's Message

The State of our Lodge is good. Our finances are in good shape and the membership numbers in various categories are essentially unchanged. We ended the year with 149 members - eight new members were initiated but eight others either resigned or were dropped for non-payment of dues. The number of regular members stands at 115 – the remaining 34 are gold card members who are exempt from paying dues. Two gold card holders passed away during the year so we had a net loss of two members. A more detailed picture of our membership is presented under the headline "Statistical Data" later in this newsletter.

The Christmas party was a great success thanks to the hard work of many people in our Lodge. I would like to thank all the people that helped out and/or donated items to be raffled out. Sonja Andonian (with able help from Kerstin Wendt) was in charge of organizing the event. We ended up with 82 members and guests in attendance. This number was somewhat less than we had last

year, probably because of competition from other events in the Swedish-American community.

Four of our active members, the Lindstrom and the Richards families, were hired to provide the Christmas dinner. People at my table were all raving about the food – it was fantastic, cooked just the way I remember from the old country. The evening's entertainment included a Lucia ceremony in which Ann Heinstdedt presented a talented group of youngsters who apparently had spent many hours rehearsing the traditional songs in Swedish – it was a beautiful performance. Lucia this year was Lauren Powers. Another popular portion of the program was the visit by Santa. Some questions popped up about permits from LAX Air Traffic Control and whether Santa flew in from the North Pole or from the local community of Northridge but in the end it didn't matter. Everyone, young and old alike, got a goody bag – no questions asked on how good they had been all year 😊

We have our first business & dinner meeting for the year on the 12th. Dorothy Reiersen, Gunilla Thelin, Lena Thelin, and Inger Sorenson are in charge of the kitchen. Hope to see you all there!

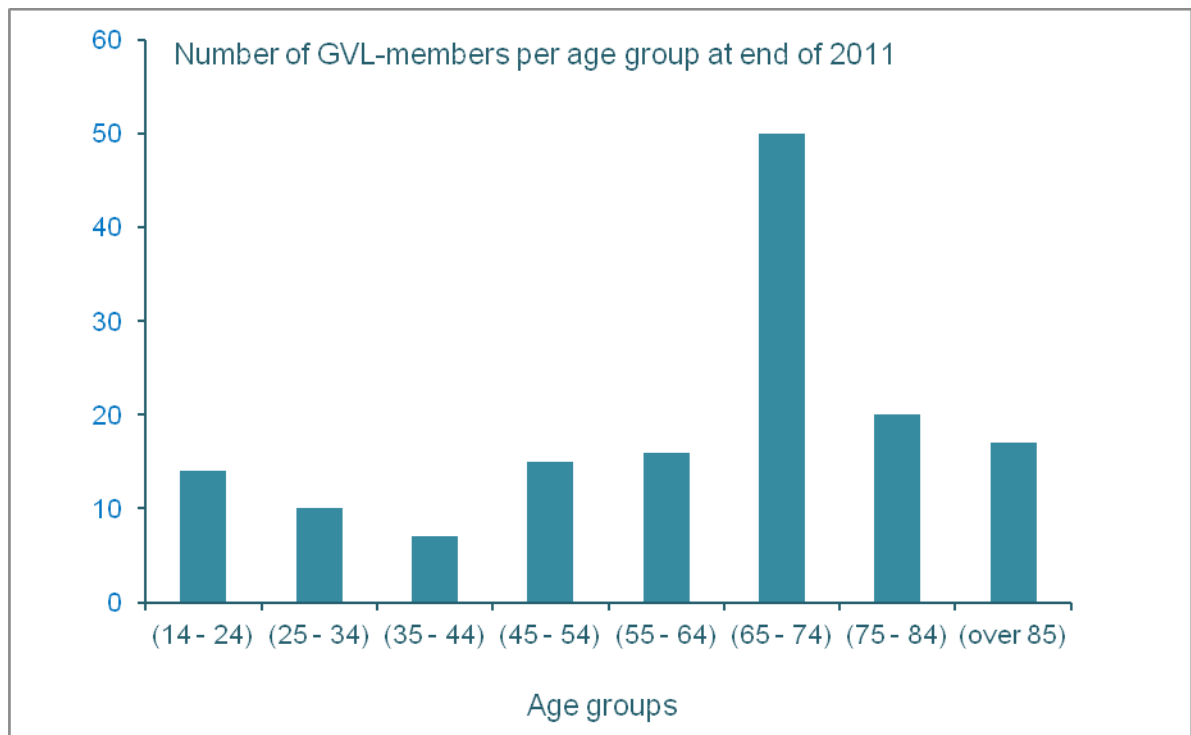

Statistical Data

For the future existence of our Lodge it is essential that we recruit new members in the younger age groups and get them involved in our activities. We have made some progress in that regard but the numbers are not improving quickly enough. It's a little bit like the national unemployment numbers – lately they have improved but not enough to have a real impact.

I have prepared a chart (see next page) showing the age distribution of our members. It comes as no surprise that the distribution is highly unbalanced. The relatively large number of members aged 65-74 is probably due to the demise of the Swedish Hollywood Club – many in that organization belonged to that age group and they joined GVL when it folded or became less active. It is interesting to note the low number of members between the ages of 35 and 44. This is the age when most people are working very hard to establish themselves in their professions and have less time to participate in social groups. A way to increase the number of members in this group would be to create activities for families with children in kindergarten or in elementary school. I understand our Lodge at one time had such an activity that operated under the name “Blåsippan”.

In 2011 the average age of our members increased from 60.9 to 61.6 – collectively we became 8 months wiser during the 12-month period. As a matter of fact, if you were born after September 1944 you belong to the youngest half (age median) of our membership. You might like that just fine but it doesn't bode well for the continued survival of our Lodge. At the business meeting in December we discussed a proposal to subsidize social events for the younger members (ages 14 to 34). I hope members of that group can agree on a suitable excursion and I urge the general membership to be generous in their support.
